Role	Member of the Engineering Standards Panel – Registered Engineer.
Term of Office	3 years, renewable for a further 3-year term.
Meetings	There are three meetings per year. Two of which are via Teams and one in- person meeting which is usually held at the IPEM Office, York in October. Additional meetings may be arranged by the Vice President Engineering if required.

Where does this role fit in? Examples of work	 Identify and monitor key engineering policy or standards issues or changes in the external environment to which IPEM should respond Identify suitable members to represent IPEM on external groups or in policy or Parliamentary forums regarding engineering Prepare appropriate responses to relevant engineering consultations for sign-off by the Vice President – Engineering and submission by the External Relations Manager Review IPEM's engineering –related Position and Policy statements regularly for relevance and update as necessary Identify the need for new Policy or Position statements, or other publications, on engineering issues, and prepare these for sign-off by the President (or as required by the External Communications Policy) Provide advice and intelligence on national and international engineering issues to the Vice President – Engineering Provide advice and information on engineering-related issues to National Office staff when required Comment on and input into relevant National Office policies and procedures from an engineering perspective.
Time Commitment	3 meetings per year + additional meetings as required.
